# 8.1 Developments related to Boxted Bridge

MN reported that the District Council had agreed to meet the parish council ahead of the planning application to replace the bridge going to the District Council's planning committee. The aim would be to ask if the District Council has any questions about the parish council's response to consultations on the application and also to find out it there would be an opportunity to speak when the application goes to the planning committee.

SG said he would investigate potential trip hazards on St Edmunds Way footpath following clearance work.

SG reported that SCC had responded to a report on potholes alongside the path in the churchyard saying it was not their responsibility. It was noted that the parish council would need to find evidence that this is a footpath before taking the matter further with SCC.
