4 MINUTES

4.1 Minutes of the previous meeting

7 PLANNING CONTROL

7.1 BMSDC Planning enforcement prioritisation strategy

It was noted that BMSDC has published an enforcement strategy outlining the criteria on which enforcement action would be considered, and that the district council had not consulted with parish councils on this. It was noted that this was effectively indicating to developers that certain planning requirements would not be enforced if considered trivial under the criteria.

Action: MN to circulate the document to neighbouring parish councils and raise with the Dedham Vale Society National Landscape Partnership.

7.2 Compliance

A response from SCC on ownership of land near One School and whether parking on it complies with regulations was noted. It was also noted that there are different views among residents and authorities on ownership of land which has been used for storing tree cuttings.

Action: MN to seek clarification with SCC.

MN reported that he and SF would be meeting with contractors to discuss closure of Scotland Street for six weeks as part of UKPN's Box Valley North undergrounding scheme. It was agreed that the committee members would circulate a note informing residents of the forthcoming closure.
