# 9 NATURAL ENVIRONMENT

# 9.1 Stoke by Nayland Resort's proposal for revised footpaths

SG reported that he had raised the possibility of the Resort seeking to designate the planned new permissive path towards the club as a public right of way as part of its proposed footpath rearrangements. The club had not rejected the possibility but challenges had been identified including lengthy procedures. The club was also looking at the possibility of applying for government funding to create a cycle path alongside the planned permissive path.

**Action:** SG to continue discussions with the general manager on maximising the value of the new walking route that would be created to the club, and the possibility of the parish council formally supporting the club's proposals.

## 9.2 Maintenance of footpaths and public realm

VK reported that ivy is strangling a tree on Clipt Bush Corner, and nettles are obstructing paths off School St.

**Action:** FG agreed to deal with the ivy and SG agreed to reinspect the path off School Street which he had previously reported as safe for use.
